FYUGP – 2024 ADMISSION NOTICE for CUET CANDIDATES only

1st Round of CUET Admissions (16th – 22nd August, 2024)

All the verified CUET candidates, who shall be allotted seats in different programs offered by Government Degree College Dooru are informed to note down the following instructions for information/confirmation of their admission in the allotted program:

1. That the seats shall be allotted to the CUET candidates only during the 1st & 2nd round of counselling on the basis of CUET Score & preferences filled in by the candidate. No seat shall be allotted to any Non-CUET candidate during the 1st and 2nd round of counselling.
2. That all the CUET candidates are advised to regularly check their admission status by logging into their registered account on the Undergraduate Admission Portal throughout the span of both the rounds of counselling.
3. That those CUET candidates, who shall be allotted any seat at this college during the 1st round of counselling are advised to 'Accept' the same through their registered account, else, they can exercise the option of 'Upgrade' by depositing a refundable amount of Rs. 2,000/-. However, failure to exercise either of the options shall amount to cancellation of the allotted seat.
4. That, if the candidate accepts the allotted seat (to be accepted from 14th August, 2024 to 18th August, 2024), he/she is advised to visit the Admission Facility of the college for physical verification of documents from 16th August, 2024 to 22nd August, 2024. Once physical verification is done, candidates can proceed to deposit the admission fees online upto the latest of 26th August, 2024.
5. That, if a candidate chooses to upgrade the preference, the candidate has to wait for the 2nd round of counselling, which shall commence from 29th August, 2024. Moreover, those CUET candidates, who have not been allotted any seat during the 1st round are also informed to wait for the 2nd round of seat allocation commencing from 29th August, 2024.
6. That the detailed admission schedule for CUET candidates and Admission Flowchart can be downloaded from the official website of the college.
7. That a separate notice shall be issued stipulating detailed instructions for facilitating Non-CUET candidates during the *Mop-up Round* commencing from 9th September, 2024.
8. This notice isn't meant for the candidates, who have not registered on the said portal. A separate notification for *SPOT ROUND* shall be issued for such candidates subject to the directions laid down in this regard by the Higher Education Department, J&K.
