

FUTURE PLANS OF ACTION FOR ACADEMIC YEAR 2024-25:

The IQAC of GDC Dooru has enumerated the following plans to be strived during the academic year 2024-25:

Institution:

- 1. The college through Career Counselling Cell shall organize Common University Entrance Test (CUET-UG) workshop in which the desirous candidates shall be imparted training for the successful appearance in the CUET test to be conducted by the National Testing Agency in May 2024 for all undergraduate courses.
- 2. The college resolves that to strengthen the academic excellence in the college, the following events shall be organized: Open Day Programme, Library Visit, Induction Programme, Open On-spot Question Answer Session, visit of some eminent people in the campus etc.
- 3. The college has unveiled a new plan of doing academic audit, green audit & gender audit in the campus as per the UGC rules.
- 4. To continuously innovate, introduce new courses and remain relevant to the changing needs of the stakeholders;
- 5. To provide thrust to achieve excellence in courses, such as Major Computer Application, Accounting & Taxation etc.
- 6. To monitor Quality Assurance and Quality Enhancement activities of the Institution.

Workshops/Extension lectures:

I. The college aims that the college IQAC in collaboration with Debates & Seminar Committee/different Lecture Series, Workshops, shall organize departments International/National Conference so that a good academic culture is maintained in the campus. 2. The college resolves that the Physical Education Department shall prepare roster for visit of students in the college gymnasium and shall organize all the activities enlisted in their activities calendar.

Infrastructure:

I. The college.ICT committee shall prepare document which, shall figure-out the digital facilities available in the college. The committee shall also take a stock of the shortfalls in the digital infrastructure in the college so that a final preparation is put in place for the successful NAAC accreditation. 6. To strive towards making commission of college canteen and starting of work on separate Science Block.

Administration

1. The College Student Help Desk (SHD) shall be strengthened and the Convener Grievance Cell shall be asked to overlook the affairs of the SHD and shall ensure the documentation of all the grievances and their resolution thereof. The committee shall also organize open grievance redressal camp in the college.

2. The college administration aims that the Placement Cell shall ensure conduct of placement drive in the campus so that the student progression is augmented. It is further resolved that to substantiate student support in the campus; the following things shall be made available in the college campus-Xerox Machine, Notices/Audio-Video Lecture/e-content to be made available on the college website, Digital Admissions etc.

3. To strengthen the availability all Information online on the College website relating to Admission, Examinations, Courses, Rules, Committees, Attendance, Activities, Programmes, Seminars, Workshops, Extension Activities, Scholarship, Grievances & Others.

4. Providing online resources to all the students.

5. To support various staff benefits and welfare measures

seeking permission To ease out the administrative process for attend workshop/conferences/RC/OP etc. by the faculty of the college.

- 3. To enter into collaboration with DLSA Anantnag for offering legal services in the Tehsil Dooru especially in the adopted village/s.
- 4. To foster and strengthen relationship of Alumni, the institute shall call an Annual Alumni Meet.

Faculty

- 1. It is resolved that the Research Committee shall ensure that every faculty member should ensure the following-publications of research papers, books, book chapters, participation is conferences, workshops, FDC, RC etc.
